- 3. Columns Update:

Kristen has been trying to contact Boston Ornamental and is awaiting a reply. This was source of one quote. Also contacting Old Bostonian and Cronanburger and Sons for quotes.

- 4. Paint color for exterior: Using Zoom, a sample of the color was shown on screen. Sample color on a similar building was also provided for all to see.
