Judy stated that she sent an email to the Town Manager and the Accountant in regards to the budget need for \$1,000.00 to pay for the doctor that Cheryl has secured for Millbury. Julie mention she requested a list of all establishments with outdoor seating and permit to serve alcohol. 110 Grill, Puffins, Wheelock, Calabria and A&D.

Public Health Nurse Update: Cheryl stated she is seeing a downward trend of COVID-19 though she is seeing younger people (under 35) testing positive. Cheryl does need PPE. Cheryl had placed an order in April and never received it. Julie said to get her a list and she will forward to EMA. Cheryl will give her order to Julie. Cheryl stated she has a nursing trailer and would like to stock her trailer. Jim asked about CareOne and mentioned he contacted CareOne and they told him that they had 0 infected staff. Cheryl said they would give him accurate information. Cheryl Confirmed. Free COVID testing is available to protestors.

New/Old Business: On June 29th at 10:00 AM, Ron and Jim want to stake out the parks for no smoking signs. They will let the office know exactly the size and quantity of signs. Ron Mentioned that Millbury Housing had put up signs limiting guests and stating as per Board of Health.
