Cheryl Rawinski, Public Health Nurse: Jim Morin asked Cheryl about the color coded case map. Cheryl stated that the Covid case numbers are exploding. She has been in constant communication with the school nurses. The younger children can't separate from adults making quarantines much longer. The Governor changed the guidance today in regards to quarantines and you can now test out on day 10 if you test negative on day 8 with no symptoms. Contact tracing is difficult, people are not being forth coming with information and will not reveal people in the household and other close contacts. People are getting angry and frustrated and people feel it is no big deal. Cheryl expects cases to rise and not enough access for maven, taking 2 to 10 days for cases to show up.

**Health Agent Update:** Julie has been busy with complaints. Employees are reporting covid violations of the places of business. Businesses are reporting cases. People are concerned about food establishments following the guidelines. Ron asked about the homeless during Covid and how they are being impacted. Julie further discussed the impact on the homeless.
