Call to Order: Jim Morin called to order the meeting of the Millbury Board of Health at 4:00 PM on February 12, 2020 in Millbury Town Hall Board of Health Office.

Approve Minutes: MOTION: Ron Marlborough made a motion to accept the minutes of the previous meeting. Seconded by Armand White. All approved.

Review/Vouchers: None

158 Wheelock Avenue: Safety Concerns in regards to the unfenced pool: Mr. Donahue who lives in the vicinity of this pool, stated that the lack of a fence around the remaining pool at this home that has burned down is a serious safety concern. Many small children in the area and pets and animals could drown. He was told by the building inspector that it was not aquatically recreational and not considered a pool. He also spoke to the Town Manager regarding these concerns. He stated that he has pictures of the pool with water in the pool that poses a drowning hazard. He further stated that he had 147 kids come to his home on Halloween. Ron stated that he also had concerns. On January 15th 2020 the building inspector did send an enforcement letter to the owner of the property. The Board agreed to have the office call F&D Trucking and have a portable fence placed around the pool only. The Board will pay for it and put a lien on the property. The office will follow up with the building inspector in regards to the enforcement letter. Judy asked if they are allowed to go on the property to put a fence.

MOTION: Ron Marlborough made a motion that this is deemed a public nuisance and they will coordinate a fence around the pool if approved by Town Manager. 2nd by Armand White. All in favour. Approved.

Marijuana Regulation: Phil Leger is consulting with legal per Julie. Tabled.



Office Hours: Judy stated she gave a copy of the minutes to Justine.




