Management Update

Sean stated he would be presenting a written management report once a month to the Board. He had received correspondence from the website from Patrick Perry on 1/22 he went to get his fingerprints taken and he had a good and positive experience with the Police Department and wanted to let the Board know. Tree Work is still being done around Town. We are working on a Block Grant. I have completed meetings with all the Departments for their Budgets, met with the Finance Committee and went over the schedule. A Bond Rating call was done for the school borrowing. For the Asa Waters Mansion we are going to use the Care Act funds to rent a tent from April-October and that will allow the mansion to have gatherings and hopefully the tent will continue to bring people back to the mansion for repeat functions. On behalf of everyone at Town Hall we wish Chief Desorcy Happy Trails and regrettably tonight's ceremony was subdued due to Covid. We hope to have a big retirement/promotion party in the late summer early fall for Chief Lewos.

Selectman Despres asked about any updates on the Care Factory.

Sean stated it has been pretty quiet and there has been no violations, we will however take a stronger line if necessary.

Selectman Delaney asked about buying the tent instead of renting.

Sean stated we wouldn't be able to use Cares Act funds if we bought a tent, we are hoping for a rent to own option.
