Sean stated that the Town has awarded \$393,800 to small businesses through the Small Business Grant program. There were 41 applications in total submitted and 33 businesses received money. The Hazmat work for the FHQ is almost done, the building will start coming down soon. Blasting will start in about 3 weeks, residents will be notified. Sean stated they have discussed traffic and dust control at the FHQ construction meetings. There are new poll workers in the Town Clerks office for elections, the office will be closed from 11am-2pm on Tuesdays. There are a couple grants in process. The mansion received a grant and there are 2 more movie showings. There's a Green Communities Grant that was used towards lighting at the high school. Woolie World was re-paved and the basketball court will be fixed soon. The Opioid Settlement is \$17,000 a year for the next 10 years, it will be spent towards Public Health Services. Shaw School opened on August 31st. Co Grow has filed their bond and they should open up soon. There is another dispensary that wants to open up on McCracken Road. There needs to be a Public Outreach meeting first. There is a new law regarding impact fees which will change the revenue the Town receives from dispensaries. The Public Outreach meeting is at 9/22 at the library 5:15pm-6:30pm. Chairman Krumsiek added Woolie World looks great. Selectman Despres mentioned there are missing lights and Selectman McKenna stated the no turn on red signs don't work on the common and Sean replied a couple were damaged but they should be fixed soon

All other Sealer fees will be per the fee schedule as set by Massachusetts General Laws Chapter 98 except, where the actual cost to the Town of Millbury exceeds the fee set by the state, in which case, the actual cost incurred by the Town will be charged.

Re-Testing & sealing of previously failed or condemned systems, equipment or devices that have been reconditioned and are ready to be put back in service will be charged a fee equal to the fee of the initial test of that equipment or device.

All New weighing or measuring equipment or devices installed in establishment and intended for trade must be inspected, calibrated and sealed prior to use.

All Price Verification systems, regardless of number of scanners, will be tested annually.

Any Adjustments made to any device will be charged a fee equal to the sealing fee of that device.

Updates:

- ARPA: A spreadsheet with ARPA expenditures has been placed in the BoS Sharepoint folder.
- Small Business Recovery Grant Program: To date, we have awarded \$393,800 in ARPA funds to 33 local businesses.
- **Fire HQ:** Hazmat remediation is nearly complete. We are optimistic that demolition of the building could commence this week. The Fire Chief, members of the Building Committee, and I have been attending weekly construction meetings at the site.
- Town Clerk office closure: On Tuesdays from September 13 through November 22, the Town Clerk's office will be closed on Tuesdays from 11am-2pm to conduct election-related work and training.
- Grants:

The Asa Waters Mansion received a \$7000 grant from Massachusetts AARP to purchase equipment and licensing to begin hosting the Millbury Moonlit Movies series. This movie series will show diversity based classic movies and will be shown with our new projector and screen under the tent. For this first year, our three showings will be the following Fridays: September 16th and October 7th.

The Town is the recipient of a \$93,106 Green Communities grant: \$22,104 for Jr-Sr High School LED lighting and \$71,002 for Sewer Main Pump Station pump upgrades and controls

- Woolie World: The parking lot reconfiguration and paving is complete; striping will be done soon. We are still waiting on bid information from Little League for the field work.
- Statewide opioid settlements: We received our first annual payment of \$17,000+/-. We will appropriate these funds at either the fall or spring Town Meeting.
- **Shaw School:** School started on time on 8/31. Work on the site of the old school will continue throughout the fall.
- Personnel:
 - We are continuing to recruit for Town Engineer, Assistant Town Accountant, Assistant Planner, and Senior Center Program Administrator.
- Town Hall generator: Site work has begun for the generator pad. Installation of the generator and new equipment shed will commence in the next couple of weeks. We expect completion prior to the winter.
- Cannabis: It appears that the Latti Farm Rd facility will open very soon. The Town is also in receipt of an application for a retail cannabis facility on McCracken Rd. I will be mediating a public outreach meeting on September 22, from 5:15-6:30PM.
