Jay Rondeau from Penny Pinchers, stated they would like to have some outdoor seating area, the area would take up two parking spaces and some space on the sidewalk. They would close the outside around 10 PM and the area would seat around 20 people. Steve Sterns asked if the barriers could have some sort of reflectors as a safety measure and is the business or town liable. Jay agreed and stated that would be the businesses liability. The outdoor seating is ADA compliant.
