# ITEM ONE - CALL TO ORDER

#### ITEM TWO - APPROVAL OF MINUTES

Marcia Landry motioned to approve the December 5, 2016 meeting minutes as submitted; Gil Picard seconded; a unanimous vote of approval was obtained.

## ITEM THREE – NEW BUSINESS

- The Commission discussed trash receptacles at the cemetery. He wants to know why we need so many. Rob said they are necessary and do accept a good amount of trash. They discussed the need for repair & restaining of the receptacles. Rob is confident they can be repaired by staff. Rob is concerned that if there was a large centralized trash container, it would be overwhelmed, possibly by non-cemetery related trash, as happened in the past. Marcia Landry said she'd like the same color stain as those at St. Brigid's Cemetery. Rob disagreed, believes it would be better that one could distinguish between the two different cemeteries.
- Rob explained the Marjorie Dudley monument matter, whereas the Comm. approved a monument but then rescinded their vote upon learning the purchaser of the monument had no rights to Marjorie Dudley's grave. Atty. for purchaser is asking for Town to reimburse him for the deposit amount he paid to have monument made and Rex Monument is seeking the balance, as the stone was made and cannot be utilized. Rob suggested to pay Rex and take possession of the stone. Randy Mogren suggested asking Rex if they may be able to use the stone in any capacity & if so, they could charge us less and keep the monument. Rob said he would make that inquiry to Rex Monument Co.

Randy Mogren motioned to pay \$1,865.00 or a lesser amount if Rex were to keep stone; Marcia Landry seconded; a unanimous vote of approval was obtained.

Rob McNeil prepared the following for the Cemetery Commission's review and signatures: Licensed Burial Rights in Central Cemetery issued to Paul F. Auclair Commission members approved and signed license accordingly.
