#### Other Business:

Mr. Stead inquired about an update to the Rice Road project. Ch. 40B presentation/plan has not been brought to the Town yet but is expected. Updates to follow as more information comes forward. Mr. Raymond asked if they would need to re-file with the Commission, which was confirmed that they would need to refile.

192 Millbury Ave is in a land court dispute with an abutter and does not anticipate doing work within the buffer zone until the legal matter is settled.

Singletary Arms, 115 West Main Street is still under appeal with the MassDEP, updates will be given when the Commission hears back.

Millbury Nature Trails Committee updates- Mr. Stead again stated that the Conservation Commission will help in whatever way is needed. A brief discussion ensued regarding the Brierly Pond Forestry project. This is a completed project and a check from the sale of the timber has been received. Mr. Stead noted that volunteers are welcome to participate in the Trails Committee's projects.
