- 1. Call to Order: Mary Wright called the meeting to order at 6:00 PM. The meeting was held remotely through Zoom due to the COVID-19 pandemic and a meeting room conflict. The meeting was streamed through Millbury Public Access Cable.
- 2. Meeting Minutes: January 18, 2022

Pam Adams made a motion to approve the January 18, 2022 minutes of the Millbury Dog Park Committee as presented. Christine Kelley seconded the motion. Vote: Aye-4.

- 3. Treasurers Report:
- a. As of 3/11/22 the balance in the account is \$22,354.92.
- b. Friends of the Butler Farm Dog Park, Inc: \$3,735.29 as of 12/21/21.
- c. Number of Registered Tags: 50 tags as of 3/11/22, 224 tags sold in 2021. Stephanie stated that she has not heard any negative comments so far relating to the increase in the price of membership. She stated that end of March and April are busy for tag sales.
- 4 Capital Improvements and Maintenance:
- a. Review the schedule for emptying and filling bags: The schedule was reviewed.
- b. Mower: The Cub Cadet has been delivered and the old mower taken away. Susan Ainsleigh made a motion to purchase a Cub Cadet XT1 (LT42) from Boston Lawnmower Company for \$2,099.99. Pam Adams seconded the motion. Vote: Aye-4.

- e. Summer Help: Stephanie will look for the job description and advertise for summer help. She will ask DPW if, when their summer help is done with their tasks, if they could mow the park. If acceptable, this plan would be put into effect if the park cannot hire someone. The ad should be put on Facebook, our website, the Town's website, and sent to the high school.

Mary Wright made a motion to order Mutt Mitt dog waste bags. Susan Ainsleigh seconded the motion. Vote: Aye-4. Stephanie will place the order.

Mike LaTour will purchase a new broom. He can be reimbursed by the Friends if he so chooses. He stated he will make the broom a donation to the park.
