

FINANCE COMMITTEE Minutes Zoom Meeting 871 4448 6667

Meeting called to order at 6:35 p.m.

Motioned by Wells, seconded by Cooney to accept the minutes of March 28, 2022 as written. Cooper, yes; Kuphal, yes; Cooney, yes; Wells, yes; O'Connell, yes

Jen O'Connell: We will be meeting with Blackstone Valley Tech tonight, then vote on the Warrant and the Budget. I hope to get it all done tonight.

Dr. Fitzpatrick, Superintendent of BVT and Chet Hanratty were in to discuss their budget.

Dr. Fitzpatrick: When we prepare our budget in January, we only have the Governor's House 1 budget to work with. You have an additional 7 students in this budget. That brings Millbury to a total of 103 students.

Russell Wells: Is the 103 a constant number or does it tend to go up and down?

Chet Hanratty: We were at 65 a few years ago. It seems to be trending up.

Dr. Fitzpatrick: The State bases their numbers on the amount of students on October 1st. We have 3 years left on the debt. We also maintain an excess/deficiency account, similar to your Free Cash. We received over 90% back for regional transportation. We applied money from both of these accounts to help control our budget. Also, our staff is very flexible about helping with improvements in our building.

Russell Wells: Have you changed our strategy on taking in students?

Dr. Fitzpatrick: Yes, we have. We lowered the academic standards. We also started a new 2 year drafting program. This is offered to students in 11th and 12th grades. Our total budget represents a 4.9% increase.

Jen O'Connell: Do you charge any fees to the students?

Dr. Fitzpatrick: We charge \$50 for any sport, with the exception of hockey. That cost \$300.

Russell Wells: Do you have any major capital projects coming up?

Chet Hanratty: We have 2 projects. One is a new roof and the other is a new Veterinary program startup.

Nicole Cooney: How much of your budget goes back into your "kitty"?

Chet Hanratty: No more than 5%.

Dr. Fitzpatrick: I also wanted to let you know that we have a new Plumbing instructor this year.

Jen O'Connell:How did you figure in the fuel in this budget?

Dr. Fitzpatrick: There is a clause in the fuel contract. If the price is lower than what we negotiated, we get the lower price. It will not go over the contracted price. There is a 5.6% increase in transportation

Russell Wells: Has your Special Ed budget grown?

Dr. Fitzpatrick: Yes, it has. Unlike the public schools, our numbers are predictable.

Sean Hendricks: I just want to let you know that we need everything by the 18th, at the latest.

Article 3-Elder Services

Jen O'Connell: Wasn't this originally \$20,000?

Jennifer Barrett: Over the past 2 years, we haven't used that much. We dropped it to \$10,000. It may end up going back to \$20,000 in the future.

Sean Hendricks: Because of COVID, many of our elders weren't taking the chance of coming out.

Jen O'Connell: Is any of the Free Cash going to be used to reduce the tax rate? Sean Hendricks: We are using over \$500,000 for a new tanker truck. We are using \$500,000 in FY23 and \$500,000 in FY24.

The Town Budget will be voted on next Monday.

Jen O'Connell: I would like to discuss the School Budget. I feel that the number presented to us is too high. We were told that there would not be any additional staff. We haven't even finished the school and it is already up over 4%.

Sean Hendricks: The buses are in the middle of their contract. That Fixed Asset stays the same. Fuel will not be an issue with this.

Nicole Cooney: They were paid for a year without even having their services used. Sean Hendricks: A reduction of \$200,000 would bring their percentage at about 3,75%.

Jen O'Connell: I would be happy with 3.8%.

Kevin Kuphal: I don't want to keep taking from the Municipal side to afford the schools.
