The board received a call from a resident about the multi family dwelling letters that went out and the resident stated that if there was no one living in the other side of the two-family residence then is there anything that a resident can do to prove it is vacant. Chairman Nelson stated that he would like a letter from the homeowner stating no one is living in the apartment. Lisa Allain had a problem with the letter stating that anyone can say that they don't have tenants just so they don't have to pay the increase.

Chairman Nelson stated that he went down to the Elm Court Pump station and they have all the heavy equipment there and are going to be either starting this week or next.

Chairman Nelson also spoke on the Clearview Project and he said he has not heard a word from the company, but he did talk with Frank O and he stated that the meters that were put in were useless because it was a dry season.
