Call to Order

Approval of the October 19, 2022 Minutes- Vote Required

Ms. Ryan made the motion to approve the minutes from October 19, 2022, seconded by Mr. Agyeman. All in favor unanimously by roll call vote (11-0)

PCO161- framing and drywall soffits under two stairs \$5,186.00

PCO189- dry erase magnetic finish needed a higher level of drywall finish \$725

PCO197- add flush bolts at two sliding glass doors in order for the doors to lock \$1,447.00

PCO 200- ledge at softball backstop to be drilled and removed \$4,221.00

This change order was approved prior to the meeting by the Finance Subcommittee. Mr. Hendricks made the motion to approve the Fontaine Change Order #22, seconded by Ms. Ryan. All in favor unanimously by roll call vote (11-0)

• Construction, Scheduling, Budget Update: Hill International and T2.

Mr. Billings of Hill International reviewed the construction budget and contingency fund. Mr. Billings and Mr. Teixeira of Hill International had a powerpoint and led the discussion. We are currently tracking at \$717,846 in current contingencies with an estimated risk of \$325,000 and a total construction budget of \$48,294,132. Some upcoming work: Install colored asphalt at bus loop, complete Musco light pole conduit and wiring, start installing turf on field, start installing fencing, gates, and backstop,

complete comfort station finishes, install main entrance canopy, playground equipment, PIP surfacing, synthetic turf field, nature pathway, gymnasium batting cage, punch list/warranty.

Some finished work- metal panels wind door paint and rough MEPs, concrete curb, bleacher pads and dugout, platform curtains, photovoltaic system is substantially complete, Musco light poles were erected and completed, bioretention basins installed, field storm draining recharge system laid on the baseball field, asphalt binder at bus loop was installed, playground equipment has started to be installed, decorative fencing was put in place.

Mr. Pine asked for an update on the school zone flashing sign. Mr. Teixeira has received a verbal quote to relocate one sign and is waiting for a paper quote to vet the company. The vendor and the DPW will be moving the sign.

#### Old Business

Mrs. Nietupski asked about the scoreboard. Mr. Teixeira said we have people looking into pricing out how much it will be. It should be significantly less than the first quote that we received. Mr. Bedard approved the \$13,000 price for the conduit to be installed.
