Green Acres Landscaping Invoice

Greg made a motion to pay the Stutman Contracting invoice in the amount of \$98,233.33, seconded by Chris W. All in favor by roll call vote. Project is about 66% completed.

Project and Budget Updates

Discussion about status of the project, scheduling and budget updates.

The status of the project and budget was discussed.

Rob mentioned the substantial and final completion dates in the site work contract. October 30<sup>th</sup> and November 18<sup>th</sup> respectively, though the change orders added eleven days to the completion dates.

The following items were discussed:

- Warranty terms and period on the athletic track surface.
- Spring mobilization should we need to apply last track surface in the Spring.
- Remaining available funds, about \$28,946.40.

- Potential Change Order Close-outs—Potential Purchases and Votes
